RECOMMENDATION:

THAT Council receive this report for information.

Background:

During the Grant in Aid process, amounts paid to the following community groups are often brought up; Nicola Valley Women in Action, Nicola Valley Heritage Society and the Nicola Valley Museum and Archives Association.

The purpose of this report is to provide some clarity and details on these arrangements. All three organizations have an agreement with the City to provide a service that is important to the City as a whole.

Nicola Valley Women in Action: \$35,000 per year. This organization runs Victim Services.

Nicola Valley Heritage Society: \$51,111 in 2019. This organization runs the Baillie House and provides tourism information services, allowing the City to meet its requirements for Destination BC funding, in providing a tourism information centre.

Nicola Valley Museum and Archives Association: \$50,000 per year. This organization runs and staffs the Museum, as well as maintains the City's archival history.

All three groups report to the City, either as a delegation at Council or with written reports.

Options / discussion

When the contracts and agreements come up for renewal, Council will be able to make decisions on whether to continue with the current arrangements.

Financial / Risk Implications:

The cost of these arrangements is governed by the agreements in place. Any increases or decisions to not continue with the agreements would be at Council's discretion.

RECOMMENDATION:

THAT the Committee of the Whole advance the funding amounts set out in the completed Grant in Aid Approval Worksheet to Council for consideration and final funding decisions.

AND THAT the Committee of the Whole recommend to Council that \$15,000 be set aside in 2020 for community sponsorships.

Background:

Council Policy 4-01 Community Grant in Aid (attached), provides for grants in aid to non-profit and community groups who demonstrate a funding need for a service or program that will benefit the community at large. This policy was updated in October 2019.

Due to the volume of paper and size of electronic files, the applications have not been circulated. Electronic copies of the grant applications along with the supporting documentation have been made available to Council for review prior to the meeting.

All applicants were informed by email of the February 4, 2020 meeting date for the grant in aid review. The email indicated that attendance is not a requirement for 2020 and the only opportunity for input would be to answer any questions directed by Council.

Financial / Risk Implications:

In the 2020 financial plan there is \$50,000 available for grant in aid requests as per the maximum amount set in the new Community Grant in Aid policy. The maximum grant per organization is \$7,500 and the maximum for a sports team or individual attending a competition is \$500. Only one application is to be submitted per organization or individual.

As per the policy, Council will review the Grant in Aid submissions and allocate funds at their discretion within the set budget amount. Council will make a final decision on the approved Grants in Aid by March 1st each year. Council may set aside a portion of the Grant in Aid budget for allocation to Extraordinary Requests during the year.

Council may provide the following direction for distribution of financial aid to successful applicants:

- In advance at the discretion of Council.
- 50% at the time of approval and 50% upon the receipt of the final reporting.
- At another time as specified by Council during the approving process.

Sponsorships:

At Council's direction, sponsorships have been removed from the Grant in Aid process and will be considered by Council separately at a future Council meeting. To date, the City has received two sponsorship requests totaling \$3,000, while six other organizations have made inquiries regarding potential sponsorships.

Upon the Committee's recommendation regarding a total funding level for sponsorship, staff will prepare a sponsorship policy for formal consideration by Council. Staff is recommending that \$15,000 be allocated for sponsorships (Council allocated \$11,500 as part of the 2019 Grant in Aid Process), though that amount can be amended at Council's discretion.

Others Consulted:

During the review process, request for information emails were sent out to 11 of the 26 applicants. Four of the applications were removed from the list, one opted out of the process on their own, two failed to provide enough financial information and one did not respond to the request. Information on the new Sponsorship application form was provided to contacts at these organizations.

Other City managers were consulted including Sky McKeown the Manager of Recreation and Facilities with regards to specific in-kind requests.

Electronic copies of the grant applications have been provided to Council for their review prior to the meeting. The grant applications will be available for viewing on the monitors and projector as required during the meeting.

In addition to the Council Policy 4-01 Community Grant in Aid, a spreadsheet with the following tabs was provided to council with pdf versions of each tab attached to this report:

- Approval Worksheet for Meeting this is the worksheet that will be displayed during the February 4th meeting with a column for an approval amount and a notes column. We are reviewing 21 applications with a total request of \$72,492.87.

 - f. Permissive Tax Exemptions This column identifies the forgone municipal tax revenue as a result of the permissive tax exemption.
- 3. **Details Removed** a list of the applications removed from the review process along with an explanation.
- 4. **Summary Capital** a listing of the 5 requests related to capital projects totaling \$29,398.58.
- 5. **Summary Operating** a listing of the 16 non-capital requests totaling \$44,094.29.

Summary:

The purpose of the February 4, 2020 meeting is to determine the 2020 grant funding allocations. Staff has reviewed all the applications and provided comments on each of the requests for Council consideration.

Council may:

- 1. Choose to allocate all or a portion of the available funding.
- 2. Choose to move all or a portion of an applicant's financial aid request to another funding program (i.e. Sponsorship Program).
- 3. Choose to defer a decision on specific applications pending additional information.

The Committee's recommendations will be ratified at a subsequent regular Council meeting.

Policy Goal

To set guidelines for allocating Grants in Aid.

Policy Statement

Council provides grants in aid to non-profit and community groups who demonstrate a funding need for a service or program that will benefit the community at large.

Policy Background

The Community Grant in Aid Policy was originally created in 2005 and revised in 2012, 2017 and 2019. This 2019 revised policy will remove the definition of two (2) Grant in Aid Categories (Short Term and Community Initiative) and consider all applications as Grant in Aid. The forms of funding will be limited to Financial Aid and In-Kind. Sponsorship funding will be removed and the subject of a new policy. The revised policy will clarify and simplify the Grant in Aid process.

Policy Objectives

- 1. Council will establish a budget for allocating Grant in Aid in a calendar year. The amount of the budget will be \$50,000, with individual limits of \$7,500 per organization or \$500 for teams/individuals participating in recognized competitions.
- A Grant in Aid should not be used for any other form or section of a taxing or local government authority, such as School Districts, Regional Districts, Hospital, etc., or organizations or functions that are primarily funded by other level of governments.
- 3. A Grant in Aid must not be provided to an "industrial, commercial or business undertaking".
- 4. Permissive tax exemptions will be considered by Council when making funding decisions.
- 5. The Financial Services Manager will advertise annually in October the criteria for Grant in Aid with a December 15th deadline for submissions to be considered for a grant in the following calendar year. Applications received after the December 15th deadline will be considered an Extraordinary Grant in Aid. Applicants are required to submit a description of their service/program/event, financial

statements for the previous year, and a listing of other funding sources. Applicants must demonstrate that the funds will be used for a program of benefit to the community and that the group is unable to raise all its required funds from other sources.

- 6. During budget deliberations Council will review the Grant in Aid submissions and allocate funds at their discretion within the set budget amount. Council will make a final decision on the approved Grants in Aid by March 1st each year, with notification given to all the applicants immediately thereafter. Council may set aside a portion of the Grant in Aid budget for allocation to Extraordinary Requests during the year.
- 7. Representatives of the organization requesting the Grant in Aid are required to respond to any requests for further information by staff, in preparation for Council consideration. Council may request further information during deliberations.
- 8. The Finance Department will respond once to organizations that have submitted an incomplete Grant in Aid application. If there is no response from the organization prior to the meeting that Council considers such applications, the Grant in Aid application will not be considered by Council.
- 9. Grants in Aid are not intended to provide on-going support and all approvals shall be considered on a year-to-year basis and continuing support should not be anticipated.
- 10. A report to Council is required by the end of the year in which funding is received detailing how the funding was used and how it benefited the community. Failure to file a report will result in no further consideration by Council for future requests from the organization.
- 11. Council may request the return of any unspent funds from the organization.
- 12. Council may require all organizations who are applying for grant funding to attend a workshop on financial stewardship and accountability.
- 13. Organizations must confirm that the City's contribution will be recognized publicly.

Grant Guidelines:

Grants in Aid are provided to non-profit and community groups on the basis that
they provide valuable programs to the community and are unable to raise all their
required funding without the City's assistance.

- Grant in aids will be used to encourage innovation that has the potential to support or contribute towards the community and the goals of Council. This includes one-time start up for initiatives or programs which will support or contribute to the community. As well the initiative funding is to assist groups who are hosting a special event or organizing the inaugural of what is intended to be a regular event in Merritt.
- Grant in Aid funding will not be provided to fund raise for a charity or an organization other than the applicant.
- Council will disburse approved Grant in Aid funds:
 - In advance at the discretion of Council, or at another time specified by Council during the approval process.
 - 50% at the time of approval and 50% upon the receipt of the final reporting.
 - At another time as specified by Council during the approving process.

Funding Classes:

1. Financial Aid:

Grant in Aid applications that include a request for financial assistance for programs or events.

2. In-Kind:

Grant in Aid applications that include a request for the in-kind use of a City owned facility.

RECOMMENDATION:

THAT Council consider and debate the Merritt and District Chamber of Commerce request that the City provide \$25,000 to the Chamber.

Background:

On November 26th, 2019 the Merritt and District Chamber of Commerce presented to Council regarding their request that the City of Merritt support the Chamber by providing \$25,000 in funding.

Originally, this request was to be considered at the December 17th, 2019 Regular Council Meeting, but the item was deferred to this Grant in Aid meeting, to be considered alongside other community organizations that have approached the City for funding.

If Council determined to support the Chamber of Commerce, it would not come from the Grant in Aid fund, as the request doesn't meet the criteria for Grant in Aid funding. As such, we have separated this item to be considered independently from Grant in Aid.

Options / discussion

- 1. THAT Council provide \$25,000 to the Merritt and District Chamber of Commerce.
 - a. Council could amend this option to provide funding in any other amount

- 2. THAT Council request further information from the Merritt and District Chamber of Commerce and defer a final decision to a future meeting.
- 3. THAT Council deny the Merritt and District Chamber of Commerce request for additional funding.

Financial / Risk Implications:

Any funds allocated to the Chamber would come from general tax revenue or from surplus. If \$25,000 is provided, it would represent approximately 0.31% of the municipal budget for 2020.

Merritt & District Chamber of Commerce Proposal to The City of Merritt - November 2019

To Whom it may Concern:

The Merritt and District Chamber of Commerce was established in 1914 as the Merritt Board of Trade and has been a contributor to the business success of this community for over 105 years, making us one of the longest standing Chambers in Canada. In 2018 when a new Board and Executive Director took over the Chamber, the tenuous financial circumstances of the Chamber were concerning to the Board and Executive Director. Since that time, the Chamber has made great strides to improve the financial situation although the Chamber continues to find the economic situation challenging as a not-for-profit organization that relies solely on Memberships and Fundraising.

In 2018, the Board also made the decision to go back to mandate and focus on event planning and endeavors that supported business. The Merritt Chamber switched gears and committed ourselves only to those things that were directly growing or supporting businesses, and the City of Merritt. At that time, we also began to build a new relationship with the City of Merritt, which had faltered for some time.

As a result of our renewed partnership with the City and desire to return to mandate, the Chamber has increased its value to the community and assisted the City in raising their profile as well. In the Chamber's opinion, this has been achieved through the following programs and initiatives:

- The creation of the Merritt Summer Nights Market. While the City of Merritt was named a sole supporting partner on this endeavor, it was not involved in the organization of the program other than by way of a small amount of the City's contribution to advertising. Money raised goes to the Chamber with a percentage being injected back into Crime Stoppers who assists with security so they may put community funds back into their safety programs. In our opinion, this market has directly contributed to new company start-ups and to the relocation of business to Quilchena Avenue.
- The Exit 290 Sign Project. By contract, the Chamber was allotted a \$10,000 grant that the City received for the creation of the map, and building of the sign structure. We have provided our man hours to contract, and coordinate the entire project at no cost to the City and removed the



responsibility of the project from their staff. While the sign project has not yet been completed, it is well underway with no direct cost to the City.

- The Chamber Executive Director was an active member of the Business License Review for which
 the Chamber and Community Futures Nicola Valley provided information and collaborated with
 the City of Merritt to assist them in the decision-making process which shaped the changes to that
 program.
- We advocated for the City at Vision Merritt to include Will George as a City Representative as well
 as Council to involve them in that business working group to improve Merritt as we believed they
 should be involved and were an asset to the process.
- The Executive Director was involved as an active member of the PNP committee which includes reviewing business plans and related paperwork, meetings with PNP Participants and assisting them in navigating business in Merritt along with Community Futures Nicola Valley, and providing informed recommendations for appropriate business plans for the City of Merritt to send recommendation letters to the government for approval. With the recent lay off of the Chamber's Executive Director, this roll has been taken on by the current President.
- The City is listed as a sole partner on every Chamber event, including Community Day, Country Christmas, Business After Business, Lunch and Learn, All Candidates Meetings, Merritt Summer Nights Market, Art Walk, etc.
- This past July, our current President, Kim McLean, and Executive Director, Meagan Preston, attended the Thompson-Okanagan Regional Consultation in Kelowna and spoke directly to the Deputy Minister of Forests, Lands, Natural Resource Operations and Rural Development, the Deputy Minister of Municipal Affairs and Housing, the Deputy Minister of Jobs, Trade, and Tech, the Ministry of Attorney General, and the Ministry of Public Safety and Solicitor General about issues directly affecting the City of Merritt. This included the Forestry Crisis, Housing Crisis, and the Opioid Crisis we are currently facing in an attempt to raise the profile of Merritt with the officials in Ottawa.
- The Chamber is helping to attract new business to Merritt by assisting and attracting franchises with accurate statistics of the business area and demographic.
- The Chamber has agreed to a partnership with the City for dual use of our Kiosk at no charge to the City.
- We have increased our perceived value in the community and we now have over 100 members,
 which is higher than it has been in a number of years.



- We support the Youth Entrepreneur program by offering free placement at the Merritt Summer Nights Market and other relevant Chamber led events, and support our young businesspeople along with Community Futures Nicola Valley who facilitates this program for the City.
- Our Executive Director and President are in constant contact with City Councilors and Staff to feed forward information, ideas and research regarding development and quick wins for the City so they may prosper, draw more tourism, and attract more business. This includes providing research and information.

During recent Roundtable Meetings that we have had with Chamber members, as well as non-members, it is apparent that the key aspect we are lacking as a City is *clear communication and <u>one</u> strong voice*. Right now, we are all working towards the same goal, to make Merritt better, but from different starting points and we need one main source for people to go with their business concerns. Furthermore, businesses need to know those concerns will be brought to the City and advocated for, currently, this is not the case. The Chamber has the potential to be that source for Merritt - with the support of the City. Small business is and will be the backbone of our community and to make Merritt a better place, we strongly feel that more resources and advocacy for small business is a benefit to all.

At the end of the day, with all of the positive strides we have made to make Merritt a better place to visit and do business, we still struggle financially to make ends meet and clear the remainder of the debt accrued prior to 2018. Because of our increased focus on business support, supporting City initiatives, and the creation of new business opportunities mandate, we no longer have the time or the desire to fundraise through avenues that do not support business. As a not-for-profit, we struggle every year to make ends meet, and this is proving to continue to be difficult and puts the future of the Chamber in jeopardy.

We have recently canvassed the other Chambers in BC for information on how the city they represent supports them. The information we received was surprising and somewhat disheartening as it pertains to our current support level that we receive from the City of Merritt. Clearly, we are valuable to be called upon for support, but we feel perhaps it is unclear that we also require support as a not-for-profit. Some Chambers do run the tourist information centers and provide marketing, or economic development support, which can lead to City infusions in excess of \$380,000 per year, whereas others are receiving in excess of \$60,000+per year just to support the business community in towns with as small of a population as 11,000.

We are asking for our City to see the value we bring to the table, to the community as a whole and ask that the City consider making a much more significant investment in us, as we continue to grow and improve



the business community here in Merritt. We are excited about the opportunities and the energy the Board brings to the Chamber but we are also cognizant that we need to find a better way to make the finances of the Chamber function to permit the focus of the Board to be on betterment of the community rather than fundraising.

In particular, we would like to ask the following be considered by the City as we continue to work together to improve and grow Merritt:

- 1. That we, the Chamber, receive \$25 \$50 from each business license fee paid annually to be able to put back into the business community through support programs like Lunch and Learns, Seminars, Business After Business, Roundtables, business growth strategies, and other events. We do recognize that the Business License fees have been reduced recently, but feel that it would be positive in the eyes of the businesses and public for the City to reallocate some of those funds to inject back into business support strategies.
- 2. That we, the Chamber, may receive support funds from the City directly to assist with the man hours that we are currently investing in supporting City initiatives, staff, and programs. The Chamber has been providing the expertise and time of our Executive Director as well as partnership branding to the City on every event, website, social media, marketing, and programs for quite some time for a very minimal fee of \$3,000 (which was originally a rental subsidy for this not-for-profit business). We are looking to review this partnership structure, so we can be of more benefit to the community and to the City of Merritt.

In closing, we sincerely hope that you see the value that the Chamber provides to the City of Merritt and to the growth of the business community and ask that we be able to meet and discuss these items further.

We are looking forward to hearing from you, and continuing to grow our partnership.
