6. GENERAL MATTERS - Delegations and Recognitions

6.1 Shirley Bobroske

Ms. Bobroske to speak about the situation of cats in the City of Merritt

Ms. Bobroske said she had lived in Merritt her whole life, and that she wanted to discuss the attention given to cats.

She explained a stray cat had moved onto her property, and detailed her difficulty gaining assistance from animal control organisations in Kamloops, Kelowna, and Victoria. She ultimately gained assistance from Sammy's Forgotten Felines in Kamloops. She wanted to see more consistency in how cats were dealt with, and more accountability to follow through with each cat, and potential fines for owners who did not care for them properly.

Cllr White arrived at 7.09pm.

Cllr Christopherson and Mayor Brown thanked her for the input. Mayor Brown said she had already discussed with Ms. Bobroske the possibility of having space for cats in the new animal pound.
