Merritt and Nicola Valley Fishing Infrastructure Project

BACKGROUNDER

The Freshwater Fisheries Society of BC (FFSBC) is embarking on a collaborative, multifaceted initiative to enhance and develop infrastructure to access the world class recreational fishing that exists within a one-hour drive of Merritt and the Nicola Valley. The area has many wild fisheries, as well as 35 small lakes stocked by FFSBC to provide recreational fishing opportunities.

An uptrend in angling activity, particularly non-resident anglers as a result of improved infrastructure and facilities will help revitalize the local rural economy. Results from the 2010 Survey of Recreational Fishing in Canada estimate that non-resident anglers each spend approximately \$188 per day on direct expenditures related to fishing in BC. This is also an opportunity to invest in infrastructure to help accommodate the recent increased interest in fishing amongst BC residents, particularly new young adult anglers as a result of COVID-19. BC resident freshwater licence sales are up 16% overall year to date and up 61% for 16-24 year-olds.

Working with local governments and stakeholder groups it has been identified that many of the world class fisheries in this area have either poor or no facilities and access constraints including dysfunctional boat launches, no shore fishing opportunities, and limited overnight accommodation. Poor or limited access has been shown to have a direct negative impact on angling activity. According to the 2010 Survey of Recreational Fishing in Canada; 17% of BC anglers did not fish as much as they would like due to poor shore fishing or boat access

Building off the success of a similar project being implemented by FFSBC on the Highway 24 corridor between Little Fort and Lone Butte, this project will include investments in new boat launches, fishing docks, and campsite facilities on recreational fisheries in the Merritt area. Proposed projects have been identified in consultation with the Ministry of Forests, Lands, and Natural Resource Operations and Rural Development, and various local stakeholder groups:

- Campsite expansion, site grading, facilities, boat launch improvements and various other improvements on up to 44 Rec Sites on stocked lakes and wild fisheries
- Stump Lake boat launch Development
- Dardanelles Lake Rec Site Expansion including boat launch and day use area
- Courtney Lake Rec Site Development
- Hamilton Lake Access Improvements
- Fishing docks on Hook and Davis Lake

It is estimated these investments will cost \$500,000 over the next 2 years (April 1st 2021 to March 31st 2023) A key driver for this project will be a successful funding application through the Province of BCs Community Economic Recovery Program. Submission deadline Thur, October 29th, 2020.
