## 8. <u>NEW BUSINESS</u>

#### 8.1 Snow removal

Oral report from Mr. Henderson and Mr. Smith

Staff will present options for Council that can be considered in greater detail at the January 29th Committee of the Whole budget.

Mr. Henderson introduced the item, and explained about Merritt's current snow removal programs.

Mr. Smith noted that the presentation was based on what staff had heard from members and residents, and asked for Council input if any more information was required.

They explained the hope to see United Way in action this year for snowclearing assistance for residents, and talked through the presentation, explaining the priorities for staff, and the capabilities of current equipment.

Councillors discussed logistical problems, including that snow in downtown had to be removed to somewhere, and that areas of the City had intermittent sidewalks, and gaps between lots resulting in no owner to shovel a walkway. It was raised that shoveling snow into the street made matters worse for neighbours when a grader drove past.

Councillors noted that BC law prohibits private citizens from driving ATVs on City highways, although it can be permissible for properly arranged municipal employees. It was also noted that Highway 8 is MOTI maintained, although property owners with sidewalks on Nicola Avenue are still subject to the City's bylaws.

Mr. Smith wanted to note that the City would be applying for the West Merritt Active Transportation Plan at the next meeting in order to seek 100% grant funding, and that the two applications could not both be funded.
